NEW LAW AFFECTS PERSONAL BELIEF EXEMPTIONS

Vaccines Protect Children From Serious Illnesses. Children who have not been vaccinated pose a risk to both the individual child and to others in their schools and community.

Make sure your child has all his/her vaccines. New Laws for families that use a Personal Belief Exemption to enroll unvaccinated children in school will take effect January 1, 2014.

For any child to enroll in a new school (including childcares/preschools) after January 2014, you must either submit proof of vaccination or submit proof of a required counseling session with a health care provider on the benefits and risks of vaccinations.

News from the California Resource and Referral Network 2013 Child Care Portfolio

Licensed Child Care in Decline Working Families Encounter Barriers to Finding Child Care

Guerneville, Calif. - As California's economy continues to recover and parents are entering the workforce in increasing numbers, access to affordable, high quality child care is essential. Working families depend on child care programs which also provide learning experiences critical to their children's development. Yet, according to the 2013 California Child Care Portfolio, a report released today by the California Child Care Resource & Referral Network, in Sonoma County there are just over 13,200 licensed child care spaces available to serve an estimated 51,900 children whose parents are in the workforce. For families able to find child care that does meet their needs, all too often high costs limit their ability to access that care.

A Lack of Child Care Supply

The total licensed child care supply in California has decreased by 3% compared to 2010, making licensed child care available to only 25% of children with working parents. In Sonoma County, the total licensed supply decreased 5%, with licensed slots available to 25% of children with working parents. Furthermore, compared to 2010 the current FCCH capacity in Sonoma County fell by 7%, while center-based care decreased by 5%.

Need for full-time care and flexible hours

Among the reasons parents are seeking child care; employment is the top factor at 77%, followed by parent in school or training at 12% and parent seeking employment at 10%. Given the variety of work schedules, it is not surprising that there is a great need for full-time care as well as care during non-traditional hours. In Sonoma County, requests for care during the evening, weekends, or overnight was at 8%. Additionally, the need for full-time care reached 82% for children 0-5 years old. Upon examining the schedules of care available, 1% of child care centers and 17% of family child care homes offer care during non-traditional hours. Child care providers offering full-time care was at 79% and 88% respectively.

Child Care is Unaffordable

A dire fact remains; 20% of the county's children aged 0-5 years are living in families whose incomes fall below the federal poverty line. For these families and many others it is an often insurmountable struggle to find high quality child care that is affordable. Nationally, California ranks 6th for least affordable center-based care for an infant, according to the Child Care Aware report: 2013 High Cost of Care. The average cost in Sonoma County is \$8,788 for full-time infant care in a child care center. Despite these high costs, over \$1 billion has been cut from the state's child care and development programs since 2008 preventing low-income families from accessing subsidized care.

Choosing child care is not an easy task. Families must consider a myriad of factors, such as cost, location,



and work schedule, in order to find a child care arrangement that meets their needs. While California has made some gains in helping working families, by increasing the minimum wage and providing more flexibility with Paid Family Leave, the state has yet to recognize the increasing importance of child care as vital resource.

The 2013 Child Care Portfolio is the 9th in a biennial series of statewide and county-by-county reports documenting licensed child care supply and demand in California. The data was collected in 2012 from local child care resource and referral programs and prepared by the California Child Care Resource & Referral Network, a statewide organization. The 69 locally-based, state-funded child care resource and referral programs (R&Rs) work to improve the quality, availability, and affordability of child care in local communities throughout the state.

Now, more than ever, you deserve to keep your money, especially during tax season. Earn It! Keep It! Save It! Wine Country provides FREE, quality tax return preparation to individuals, families, and seniors. To qualify for FREE tax help and possible earned income tax and child care credits, your household income must be less than \$50,000. Being a U.S. citizen is NOT a requirement.

The tax sites also ensure eligible taxpayers claim the Earned Income Tax Credit (EITC), one of the federal government's largest resources for low-income residents. It reduces the amount of income tax low-to-moderate income families are required to pay, and provides a wage supplement to some families. According to the New America Foundation, thousands of Californians fail to claim EITC. Families and local economies suffer when these refunds go unclaimed.

What to bring to an Earn It! Keept It! Save It! site:

Even the youngest of children can be affected by the chaos and anxiety that sometimes surrounds the holidays. Below are some relaxing activities that a family can do together that may help to reduce stress and ensure a more enjoyable holiday season.

- Spend some time in the kitchen with your children making simple holiday goodies for friends and neighbors. Even toddlers can dip pretzels into chocolate or put sprinkles on cookies.
- Make homemade holiday cards for friends and family. Use fun craft materials such as pompoms and squiggly
 eyes to boost creativity.
- Spend an evening watching past holiday videos of your family.
- Make a "What we are thankful for" family journal, assigning each family member their own page. Include drawings and photos to make the journal complete.
- Take a walk to find treasures in nature. Bring your treasures home and make them into a decorative wreath.
- Help others together. Volunteer as a family at your local food pantry, animal shelter or even as Salvation Army bell ringers.
- Make simple holiday decorations and ornaments for your home.

Children and Holiday Stress

When parents are stressed during the holidays, their children will pick up those feelings and react accordingly. The following stress management tips will help both parents and children recognize holiday anxiety and feel less stress - because helping kids cope with holiday stress is the best way to enjoy the festivities!

- Infants and toddlers: At this age the upset in children's routines and predictability are the main contributors to holiday stress. Try to schedule activities around naptimes and mealtimes. Keep bedtime routines as close to normal as possible. Watch for signs your child is becoming stressed and overly tired- fussiness, ear pulling, and clinging behaviors. Don't forget your child's favorite blanket or stuffed animal when you run errands or travel. A bit of home will reduce your child's holiday anxiety.
- **Preschoolers:** Your little ones are now old enough to experience the excitement and anticipation of holiday celebrations. However, they can become over stimulated easily. This can lead to tears of frustration and a regression to younger behaviors such as toileting issues, eating with hands, or thumb sucking. Keep plenty of healthy snacks available when you're out shopping or visiting to ward off hunger related tantrums. Be patient with your child during these stressful times and remember when the holidays are over things will improve.
- Older children: Extra curricular activities at school and worship during the holiday season can add a great
 deal of stress. Be on the lookout for signs your child is feeling anxious or overwhelmed- stomachaches,
 headaches, fatigue, and nervous behaviors such as nail biting. Do the best you can to see that your child is
 getting plenty of rest and eating regularly. Ask them to tell you how they feel and what can be done to help
 them be more calm and relaxed.



CPR/First Aid Training UPDATE:

RCCS has funds to help reimburse child care providers for the cost of First Aid and CPR training. Trainings must follow the following guidelines in order to be eligible for reimbursement:

THE FIRST AID COURSE is at least 4 hours long and includes instruction in several illnesses and injuries (such as burns, diabetic emergencies, seizures, fainting, bleeding, shock, environmental exposure, bites and stings, dental emergencies, eye injuries, head and neck injuries, respiratory emergencies, fractures and sprains, toxic substances, wound care, choking, rescue breathing) and their symptoms and first aid treatments, including protecting oneself while providing first aid (universal precautions). The course also includes instruction in preparing for emergencies, including first aid kits, first aid action plans, working with parents and children during an emergency, emergency planning, and injury reporting. The courses are lay-person and child-focused. Skills practice and testing of certain skills are included (splinting and care for bleeding, and wrapping a sprain or strain).

THE CPR COURSE is at least 4 hours long and includes instruction in infant, child, and adult CPR and AED (Automated External Defibrillator) for infant, child and adult. The course focuses on skills practices and testing of CPR and using the AED.

In order to recieve a reimbursement, providers need to have a special reimbursement form signed by the trainer at the end of the course. Most trainers have this form, but you may also obtain one from Mendy Behrens at RCCS. Call her at 869-3613 ext. 117 to arrange to get the required paperwork *before* you go to your scheduled trainings.





The Emergency Resources Program at RCCS Parents, did you know...

IF your children need food, infant formula, diapers, lice treatment, or other over-the-counter medications, such as acetaminophen, you may access the RCCS Emergency Resources Program. All that West County families need do is come by and pick up the items. Families whose children are enrolled in RCCS subsidized child care programs are eligible too. We will need the zipcode of your residence and a contact phone number.

For lice treatment, infant formula, or OTC medications, the family should call RCCS before coming by, to assure that the items are on hand in the office. Food and diapers are usually on hand Monday through Friday, 9AM to 5PM at the River to Coast Children's Services office located at 16300 1st Street in Guerneville.

El Programa de Emergencia de RCCS Padres, ustedes saben que...

Si sus hijos necesitan comida, formula para bebes, pañales, tratamiento contra el piojo, o cualquier medicamento que se puede obtener sin receta, como acetaminófeno, usted puede tener acceso al Programa de Emergencia de RCCS. Todo lo que las familias del West County (el oeste del condado) tienen que hacer es pasar a recoger los artículos. Las familias que reciben subsidios de RCCS también son elegibles. Necesitaremos el código postal de su residencia y su número de teléfono.

Para el tratamiento contra el piojo, formula para bebes, o medicamentos que puede obtener sin receta, es necesario que la familia llame a RCCS antes de venir para confirmar que tenemos los artículos necesarios en la oficina. Comida y pañales normalmente están disponibles de lunes a viernes de 9am a 5pm en nuestras oficinas localizadas en 16300 1st Street en Guerneville.
